Approved at the first program communication meeting of the 112th academic year on November 26, 2023, and at the second college affairs meeting of the first semester on December 1, 12023, and promulgated in full text. 第一條 國立臺灣大學基因體與系統生物學學位學程(下稱本學程)為維護研究生之學位論文品質, 依國立臺灣大學精進學位論文品質實施辦法訂定國立臺灣大學基因體與系統生物學學位學 程學位論文品質與管考準則(下稱本準則)。

Article 1

The National Taiwan University Graduate Program in Genome and Systems Biology (hereinafter referred to as the program) has established these Thesis Quality and Management Guidelines (hereinafter referred to as the guidelines) in accordance with the Implementation Measures for Improving Thesis Quality at National Taiwan University to maintain the quality of graduate students' theses.

第二條 本學程研究生之論文指導教授資格依國立臺灣大學學則第六十九條規定辦理。每位學程教 師每學年所指導研究生人數,核心教師上限為二人,非核心教師上限為一人。

前項如有異議,由本學程學程會議協調之。

Article 2

The qualification of thesis advisors for graduate students in the program shall be handled in accordance with Article 69 of the National Taiwan University Academic Regulations. Each program faculty member may supervise up to two graduate students per academic year for core faculty and up to one graduate student per academic year for non-core faculty.

If there are any disputes regarding the above, the program meeting shall coordinate them.

第三條 研究生之學位論文須符合本學程專業領域,並經學位考試委員會確認,如有不符本學程專 業領域爭議,依國立臺灣大學研究所博士暨碩士學位考試規則辦理。

Article 3

Graduate students' theses must align with the program's professional field and be confirmed by the degree examination committee. In case of disputes over the alignment with the program's professional field, the matter shall be handled in accordance with the National Taiwan University Doctoral and Master's Degree Examination Regulations.

第四條本學程研究生辦理畢業離校程序前,須繳交定稿學位論文之「學術倫理暨原創性比對聲明

書」。比對相似度應低於百分之二十五。如未符合所訂標準,須敘明具體理由並經學務委員會確認,始得辦理離校手續。

Article 4

Before completing the graduation procedures, graduate students must submit the "Academic Ethics and Originality Comparison Statement" of the final thesis. The similarity rate should be less than 25%. If the standard is not met, specific reasons must be provided and confirmed by the academic affairs committee before the graduation procedures can be completed.

第五條 論文原創性比對原則如下:

- 1. 排除自我引用、材料方法、參考文獻、目錄及附件,進行論文比對。
- 2. 比對時於 Turnitin 中,設定 Filters and Setting:

排除 Quotes

排除Bibliography

排除 Exclude Source that are less than 3%

Article 5

The principles for originality comparison of theses are as follows:

- 1. Exclude self-citations, materials and methods, references, tables of contents, and appendices from the comparison.
- 2. Set the following filters and settings in Turnitin:
 - o Exclude Quotes
 - Exclude Bibliography
 - \circ Exclude Sources that are less than 3%
